# What Services does a Family Justice Center Provide?

amily Justice Centers are unique from site to site and often reflect the services already available in the host community. Working as a team and utilizing a shared intake, assessment and scheduling process, FJCs are able to provide clients with easier access to a greater range of services than any single agency or organization can provide alone. The client is then able to receive both short- and long-term services through follow-up visits at the same location rather than having to research and then access multiple independent service providers at multiple locations. Some of the services that will be available at Ventura County's Family Justice Center include:

- Forensic, medical, and public health services
- Local law enforcement interviews, restraining order, victim compensation, and safety planning assistance
- Mentoring, childcare, educational, and workforce development
- Crisis and long-term mental health counseling
- Substance abuse counseling
- Financial planning
- Civil legal assistance with family law matters
- Public benefits assistance
- Emergency shelter and long-term housing assistance
- Emergency food, transportation, and clothing assistance
- After-school programming, and tutoring
- Camp HOPE
- Spiritual support and many others

# Camp HOPE

amp HOPE is a crime prevention strategy that operates in collaboration with Family Justice Centers sending children to a week-long camp in the summer at no cost to the campers' families.

The vision for Camp HOPE is to break the generational cycle of family violence by offering healing and hope to children who have been exposed to the trauma and abuse of family violence. Our goal is to give children their childhood back and help them find a Pathway to HOPE.
