- Take down the cart 830/130 a bit earlier at first?
- PD can't counsel clients till they get discovery
- Put files out alphabetically, snaked up and down
- Each agency has its own color
- Log in to e-mail and VICIJIS, calendar DA tab
- Discovery process:
  - Check PD box and date
  - Private attorney: check atty box business card date
  - Why this is helpful (PDs constantly re-requesting discovery)
  - Our copy is always on top, usually color
  - Defense copy always on bottom white w green discovery memo
  - Put back in stack

- Private attorneys requesting additional evidence
- 1054 no discovery obligation yet- but we will provide discovery if requested and the DDA takes charge

- VOPS: 5 VCJ unrelated, 10 related—Brent does not like this rule; try to look into criminal history with time

#### DUIs:

- Hirsch wants to know driving pattern/collision, prior record, BAC, and if there is anything else aggravating (t/c, refusal, kids in the car, out of time priors, speed allegation – make sure its charged)
  - (ADD Speed allegation VC 23582 30 over highway 20 over all other; 60 minimum consecutive)
- Filing deputies pretty good about noting TCs but sometimes won't
  - Read the report and check for restitution
- TS means traffic stop
- Anything else on the offer sheet (out of time priors, etc.)
- Undercuts us 10% of the time, when he does they have to eat the sheet, Nolo all counts
  - When case comes back from PTC he asks was a motion run and will offer arraignment over our objection when no motions
- IF they take our offer dismiss the other count (check offer sheet)
- Watson Advisement
  - With 977 ask the court to inquire
- EM on the record other handout
- Out of county probation/ prop ok

#### INDEPENDENT DISCRETION:

- 14601 matrix, learn it, love it, be it
- Otherwise, not much. Say no if you're confident or call Brent. PD's asks about:
  - Reckless driving enhancement trial issue
  - o Dump the .15 allegation
  - Dump refusals (Birchfield!!)
  - Random stuff like speed contests, false evidence of registration, interlock
  - o Takeaway: say no or call Brent

#### CORUTROOM 11 - DRUGS AND IN CUSTODY

#### THE PLAYERS:

- Tim and Sheila
- Judge Castillo. Will want to know:
  - Thefts: Stay away address
  - OR release: object to OR if lots of FTAs or violent criminal history, victims, permanent address
  - Criminal history on RAPs, get good at reading local RAPs, convictions
  - Facts of priors with warrant decs in VICJIS
    - Case # >> Actions >> Generate Facesheet >> Warrant Dec

#### 647fs:

- Read 647fs after doing discovery, flag ones that should be dismissed
- IF you let one through for jury trial you must notate it be assigned to you
- 415(a) infraction but only infract if the facts fit this charge

#### INDEPDENT DISCRETION:

- Dismiss 647f if no PBRD or amend to 415 infraction IF applicable
  - Tab 19 dismissal note
- Infract 484 IF:
  - Under \$50
  - No prior theft convictions
  - No evidence of planning w another (conspiracy)
- 3 open drug cases pg one dismiss the others
  - As long as all counts are drug related it counts as a drug case (11364, 11550, 11377)
  - Prop or DEJ on the table
- Strike current Prop w/ admission of VOP, dismiss up to 3 open Prop cases
- Woblettes
- Everything else: say no or call Brent

#### VOPS:

- Rejected filings we'll have a discovery packet but otherwise won't!
- Violations filed by Probation will be in VICIJIS
- Sometimes there's a VOP that's not a rejected filing and not filed by probation...

o Check the docket; the docket is your friend

### MISC.:

- Restitution is always TBD! Better for probation
- If PD needs to borrow file have clerical make copy
