SUBJECT: BOARD MOTION ON THE DEFERRED ACTION FOR  
CHILDHOOD ARRIVALS (DACA) PROGRAM REPEAL

DATE: OCTOBER 5, 2017

The Board of Supervisors (Board) has directed various County departments to assist Deferred Action for Childhood Arrivals (DACA) recipients, including those employed by the County of Los Angeles. This action was taken in direct response to the September 5, 2017 announcement that the DACA program will end on March 5, 2018. The repeal necessitates that individuals eligible for DACA take immediate action and renew their status by **October 5, 2017**, if it expires before March 5, 2018.

The Board has directed the Office of Immigrant Affairs (OIA) to work with the Department of Human Resources (DHR), County Counsel, and other County departments to explore immigration relief and residency options for County employees possibly impacted by the DACA program repeal and provide them with available resources. In response, DHR seeks all County departments with resources, to offer assistance to our employees, their families, and impacted communities.

The OIA has also developed an updated DACA-related poster that will be used in multiple communication streams by the County of Los Angeles (attached).

The County strongly supports the protection of all DACA residents within Los Angeles County and will make every effort to provide effective and informative services to assist them.
