Created through the San Francisco Sentencing Commission, in collaboration with the Sheriff's Department and the California Policy Lab, The Justice Dashboard is part of a larger movement within the City and County of San Francisco to use data, technology, and research as tools to reduce incarceration and racial disparities in our criminal justice system.
