We apologize for the short notice, but we are hoping many of you will be able to join a Zoom call at 2:30 tomorrow to discuss our priorities as bills hit the Floor. As we mentioned, the herd was culled in some substantial ways on Thursday, but there are still a number of bills to oppose.

We have highlighted 10 that we think are prime topics for consideration. Tiffany has identified the ones that require 2/3 to pass as that should probably factor into our discussion.

We've also attached the updated analyses that we have received so far from Leg Committee members and will continue to send others out to you as they come in. As I think we've noted, all of these bills have to be out of the house of origin by Friday, June 4. The Legislature will likely be meeting every day next week, instead of just Monday and Thursday, in order to get them all out. So we need to be geared to go.
