For further context regarding the request for clarification, the below categories were agreed upon by Mr. Haile for the last request, and it would be useful to understand what specific data you are seeking for the updated request.

1. Sex, race, age at time of crime, zip code of minor, zip code of crime location, crimes charged, crime charge results (what minor was convicted of or plead to), for all minors prosecuted in **adult court** in 2017 and 2018 after a transfer hearing in juvenile court per Welfare and Institutions Code (“WIC”) section 707.
2. Sex, race, age at time of crime, zip code of minor, zip code of crime location, crimes charged, crime charge results (what minor was convicted of or plead to), for all minors prosecuted in **adult court** in 2017 and 2018 after the minor waived his transfer hearing after the LADA filed a transfer hearing motion in juvenile court per WIC section 707.
3. Sex, race, age at time of crime, zip code of minor, zip code of crime location, crimes charged, crime charge results (what minor was convicted of or plead to), for all minors prosecuted for any misdemeanor in juvenile court in 2017 and 2018.
4. Sex, race, age at time of crime, zip code of minor, zip code of crime location, crimes charged, crime charge results (what minor was convicted of or plead to), for all minors prosecuted for any felony in juvenile court in 2017 and 2018.
5. Sex, race, age at time of crime, zip code of minor, zip code of crime location, crimes charged, crime charge results (what defendant was convicted of or plead to), for all **adults** prosecuted for any misdemeanor in **adult court** in 2017 and 2018.
6. Sex, race, age at time of crime, zip code of minor, zip code of crime location, crimes charged, crime charge results (what defendant was convicted of or plead to), for all **adults** prosecuted for any felony in **adult court** in 2017 and 2018.
