The Los Angeles County District Attorney's Office (LADA) is in receipt of your California Public Records Act (PRA) request dated February 18, seeking:

"On July 23, 2021, we submitted a CPRA request to your office also seeking records relevant to the implementation of the RJA. This CPRA letter is a further request for the following records regarding relevant case, individual, and/or charge-level data in the possession or control of Los Angeles District Attorney's Office for all cases considered for prosecution and/or prosecuted during the time-period 2015 to Present:

Due to the amount of data requested, we have conducted a search of the LADA's Prosecutors Information Management System (PIMS) database using the criteria provided in your PRA request and have identified records that are responsive to your request. Please be aware, to provide the numerous records you have requested, a computer program containing your search terms was created to access the records. The records contained in PIMS may have been imported from systems managed and maintained by departments and agencies outside of LADA, and we cannot guarantee the accuracy of those records. Additionally, there may be instances where information was inadvertently omitted from PIMS or was omitted from the records of outside departments and agencies which LADA imported into PIMS. Unique identifiers, represented as a Mask ID, have also been utilized with this data set where appropriate.

Given the voluminous amount of data requested, an individual search through case files cannot be conducted. Data that is not captured in PIMS will not be provided and is exempt for production because it is a burdensome request. Additionally, this also applies to certain instances in which PIMS reports multiple data which would necessitate an individual review to determine which data point is accurate. See *American Civil Liberties Union v. Deukmejian* (1982) 32 Cal.3d 440, 452-453; *County of Los Angeles v. Superior Court (Kusar)* (1993) 18 Cal.App.4th 588, 591-592.

PLEASE NOTE THAT THE DATA PROVIDED WAS GENERATED BY A COMPUTER PROGRAM WHICH INCORPORATES MULTIPLE COMPUTER SYSTEMS, SOME OF WHICH ARE MAINTAINED BY OTHER GOVERNMENT ENTITIES. ANY OMISSIONS OR ERRORS WERE INADVERTENT. WHILE WE STRIVE FOR ACCURACY, THE ONLY

WAY TO COMPILE THE LARGE AMOUNT OF DATA WAS TO UTILIZE A COMPUTER SYSTEM THAT DRAWS INFORMATION FROM SEVERAL SOURCES. THE LADA CANNOT VERIFY THE ACCURACY OF IMPORTED INFORMATION. ADDITIONALLY, INSTANCES IN WHICH THE DATA IS OMITTED OR IS REPORTED AS “NULL” OR “UNKNOWN” MAY BE A RESULT OF USER ERROR, INTERFACE ERROR, OR THE LACK OF AVAILABILITY OF THE DATA. LADA REVIEWED EACH ITEM OF YOUR REQUEST AND PROVIDED ALL DATA AVAILABLE TO LADA.

Regarding sentencing/disposition information: In most instances, the Los Angeles County District Attorney’s Office (LADA) does not directly input sentencing information into its computer system and may have been imported from the court into the LADA system. The LADA cannot verify the accuracy of this imported information. The sentencing information provided may be inaccurate. All sentencing information should be verified by the court.

4. ADA assigned to the case

PIMS reports multiple data points or is incomplete, and an individual review of each case would be necessary to determine which DDA was assigned to an individual case. Given the voluminous amount of data requested, an individual search through case files cannot be conducted because it is a burdensome request. See American Civil Liberties Union v. Deukmejian (1982) 32 Cal.3d 440, 452-453; County of Los Angeles v. Superior Court (Kusar) (1993) 18 Cal.App.4th 588, 591-592.

Please note that the identity of is generally unknown at the time of filing, therefore PIMS does not capture this data. However, instances in which this data was later entered by LADA was included in the data set.

This information is not captured in PIMS. Given the voluminous amount of data requested, this information will not be produced because it would require an individual search through case files which will not be conducted because it is a burdensome request. Given the voluminous amount of data requested, this information will not be produced because it would require an individual search through case files which will not be conducted because it is a burdensome request.
