Thank you for your e-mail and request for confirmation that the check you sent in regard to a previous PRA request and query was received. Although I have been out of state and unavailable for a time, I am returned and can confirm that the check was received and is currently secure in our business office.

I am aware that by that payment you have requested that this Office proceed with the design and execution of a query to gather as much information as is available concerning your broad records request, even though our case management system was not designed for such retrieval. I do not know how successful the query will be, because, as previously mentioned, we are not able to determine the extent to which data was entered into some of the fields. However, I have requested that Mr. McWilliams begin his efforts and I will make an effort to assemble a response to your request by the end of August. You may well receive a reply prior to that date, but I do want to make sure I leave sufficient time for Mr. McWilliams to work with the system thoroughly and allow myself an opportunity to review the retrieved data prior to sending out a reply.
