Delightful to speak with you on the phone today. To recap the areas we discussed:

1. Policy - The Mariposa County District Attorney's Office does not currently have any written policies at all in this area. We would welcome for our consideration any proposed policy from the ACLU. I have been working with an intern this summer on drafting a policy, but that is in its preliminary draft and needs more work. If you would like a copy of that draft, I can certainly send that.
2. Training Materials - Any and all training materials on this issue have been provided by the CDAA, which, I understand you have a copyright waiver from the CDAA for these. Again, I would be interested in hearing about any training that the ACLU is providing in this area.
3. Communications Re Implementing the Racial Justice Act - To my recollection, our office has not written any emails about this topic except in response to your emails asking for some proposed policies and data.
