Thank you for your response and for the work on our request. Upon review, we have determined that we do want all of the available data, including the remaining 2/3 of the data you produced in July.

Please be advised, this first rolling response following the attached response to your request constitutes 4,280 pages out of an estimated 12,000 responsive pages of data. Importantly, this first production represents **two (2) months** of one District Attorney staff member's time which significantly interfered with that office's services. He was required to *manually* redact each entry. As a result, redaction of the

remaining approximately 8,000 pages would be at a significantly slower rate. If there is any way you could review this production and let us know if this production of roughly a third of the total records would satisfy your request, our client would appreciate the consideration.

Unfortunately, the electronic file size of the above referenced documents is greater than the County of Tuolumne's maximum file size to send via email. Please respond with an alternative method for delivery of these records.
