Thanks for a productive call yesterday. I'm writing to follow up on our conversation about confirming production.

For the February request: We need to reset our password for the portal where the data was produced, as we only have the "key" spreadsheet in our possession currently.

For the July request: We are currently in possession of attachments 1-8 and 13-44. I assume this means we need you to resend attachments 9-12 and any after attachment 44.

Based on our phone conversations, I do not think we are currently discussing any withheld documents: No policy documents or training materials are being withheld to my knowledge and we are still working on accessing the relevant email communications. If this is incorrect, please let me know and resend any correspondence discussing the withheld documents.
