

We have sought a written CPRA response from your office for a full calendar year. We sent an initial letter in November 2021, called your office multiple times over the subsequent months, sent several emails following up, and mailed letters via certified mail in March and November 2022, before getting your first written response since August 2021 last week. Even setting aside that these requests are over a year old, and that your office has plainly flouted its legal obligations under the CPRA, it is clear that there remains a significant misunderstanding between our offices regarding the substance of our request. Under these circumstances, a meeting is essential to efficiently resolve these issues.
