Dear Mr. DeClark,

I was able to get a reply from the vendor last week, paraphrasing:

The 8 hours quoted is already at a reduced charge, and the project could actually take longer than 8 hours to complete.

I knew you were looking for a firm / definite quote, so I followed up this week and asked whether the \$1,820 is a set, not-to-exceed amount, or is the total price anticipated to increase? The reply is that:

An "official price quote" is only available when the scope of the project is defined and documented and sent off to the sales department for an official price quote.

A project manager did clarify the rates as follows: Development work 195.00 per hour, PM Management Services 25% of the price. In this case: 8X195=1560.00 plus 25% 390.00 total of \$1950.00.

The contact at the vendor cannot give a do not exceed amount at this time as this is not her area of expertise; she can only convey the information she receives from the sales department.

Please let me know what your client is willing to pay up front to get the data extraction started. Then, I can work with our IT Department and the vendor to obtain a firm not to exceed cost.

Mr. Havens,

As you know, an estimate for cost shifting under the CPRA must be necessary and reasonable. An estimate for \$200/hour exceeds what is reasonable in these circumstances. Further, the additional 20 percent fee is simply adding cost to the public's right to access records and does not cover any actual work performed. This is clearly not necessary. Please request that your vendor waive this fee and provide a more reasonable rate. Alternatively, we ask that you do not shift the cost to us, as it is not necessary or reasonable.

We also object to your withholding of diversion and plea offers as work product. The protection offered by the work product privilege can be waived by the attorney's "disclosure to a person, other than the client, who has no interest in maintaining the confidentiality of a significant part of the work product." OXY Res. California LLC v. Superior Ct., 115 Cal. App. 4th 874, 891, 9 Cal. Rptr. 3d 621, 636 (2004) (quoting Jefferson, Cal. Evidence Benchbook (3d ed. 2003) § 41.6) (alteration omitted). This is because disclosure to a third party is inconsistent with the purpose of the work product protection, "which is to safeguard the attorney's work product and trial preparation." Raytheon Co. v. Superior Ct., 208 Cal. App. 3d 683, 689 (1989). Disclosure to a party that has "an interest in maintaining confidentiality exists when the parties are aligned on the same side in the litigation and have a similar stake in the outcome." McKesson HBOC, Inc. v. Superior Ct., 115 Cal. App. 4th 1229, 1240 (2004). A prosecutor and the target of the prosecution are not aligned in litigation, "and they do not share the same stake or have the same goal." Id. (providing document to U.S. Attorney's Office and Securities and Exchange Commission waived work-product protection). Because the plea offers are shared with defendants, that material is not protected by the work-product privilege. We ask that you produce this data.

Eric,

Thanks to you and Jose for talking today. To summarize:

Data Request

We looked over the table you provided in your 5/24 letter to our office, in response to our 9/7/21 data request. After talking with Jose, we learned that some of the categories marked as "3" should in fact be "2," since the information is collected but is not easily accessible.

For next steps, you said that by **August 8**, you will:

- 1. Review the table with Jose (a staff person at the DA's office) to confirm that all the cells marked as "3" are in fact "3s."
- 2. For all categories properly marked as "2," you will subcategorize them as either "2.A." (which means that the IT department (or third-party vendor) can write a code (or create a similar automated process) to pull the data) or "2.B." (which means that the data can only be pulled manually).
- 3. You will provide a cost estimate and estimated production deadline for all data that falls into the "2.A." category.

Policy Request

Regarding our 7/23/21 policy request, it appears from our records that you provided a letter on 12/10/21 claiming to provide all responsive records in the county's possession. However, that production included a single email with a one-page attachment. It seems implausible that a county of any size would have zero records responsive to the request we sent. Can you please confirm?
