Data elements are missing from various parts of our case management system, which are interconnected. We are working with expert data analysts to ensure that the district attorney's case management system is accurate. The data experts have made it clear that the database, in its current format, is inappropriate to distribute for the purposes of analysis. Moreover, we have asked the experts if there are subsets of the data that can be shared and they have, in no uncertain terms, informed us that any data shared at this time likely contain important and critical flaws or omissions.
