# MISDEMEANOR CONSEQUENCES:

#### **FINES:**

Make sure MINIMUM \$220 fine is ordered on all misdemeanors; so victim compensation fund will get its share.

Most misdemeanors require minimum \$150 and max \$1000 fine.

For Standard DUI and 14601 fines, see the Court's Sentencing Guidelines.

## DV PROBATION TERMS (PC 1203.097):

PC 1203.097: ANY CRIME where the Defendant/victim relationship defined in Family Code 6211. FC 6211 includes: spouse, cohabitant, former cohabitant, dating relationship, former dating relationship, person with whom the Def. has had a child, family member within 2nd degree of affinity (parent/child, brother/sister, blood relative of spouse, etc.)

FC 6203 definition of "abuse": causing or attempt to cause bodily injury, sexual assault, placing a person in reasonable apprehension of imminent serious bodily injury to self or another; AND any behavior which has been or CAN BE enjoined under FC 6320.

FC 6320 "behaviors": all assault crimes, threats, PC 528.5 or 529 (false personation), harassing, molesting, annoying telephone calls including texts, e-mails etc; destroying personal property, making contact if enjoined, DISTURBING THE PEACE of the other party.

#### PC 1203.097 mandatory terms:

- -Probation for at least 36 months (can be summary)
- -One year batterer's program; must require weekly attendance; must have been approved by the probation dept. IF Probation says person not appropriate for BTP; judge can order alternative; but program must have been approved by probation dept. 1203.097(a)(9).
- -Minimum "fee" \$500 (not subject to reduction for time served)
- -Booked within one week of sentencing (if not already booked)
- -Criminal protective order (no math ok)
- -Community Service at Court's discretion.

#### **PROSTITUTION:**

### PC 647(b) Consequences:

- -1 yip
- -10 days jail (ok to offer 5 at EDP ONLY)
  - 2<sup>nd</sup> offense, 45 days jail minimum
  - 3<sup>rd</sup> offense, 90 days jail minimum
- -Aids test and education program (PC 1202.6)
- -Fine \$700
- -If case involves internet ad, take it down
- -if case involves particular location, stay away

## FIREARMS RESTRICTION (PC 29805 and PC 29800):

PC 29805: No Firearms for 10 years
